ENTRY TO THE REFINERY AREA FOR LOADING STERCOSUL®:

Entrance for trucks is permitted with an entrance card only. You can apply for two types of entry cards:

- a) Single (one-time) entry card (if you enter only once)
- b) Permanent entry card (if you enter the area regularly)

SINGLE ENTRY CARD

Instructions for issuing the Single entry card are listed in ANNEX No. 4 (Safety and navigation instructions).

PERMANENT ENTRY CARD

Instructions for issuing the Permanent entry card are listed in ANNEX No. 4 (Safety and navigation instructions).

If you wish to issue a Permanent Entry Card for your driver, fill in the form ANNEX No. 3 (Establishing a customer / delivery). When filling the form mark in cell „Permanent entry card“ option „YES“. Please send filled form to logistics@stercorat.eu.

For getting the Permanent Entry Card, your driver has to attend the entrance training. Stercorat SLOVAKIA, s.r.o. will organize and do the Reservation of training for your driver – Stercorat SLOVAKIA, s.r.o. will send you Reservation confirmation – date and time of the training.

Training takes one hour and needs to be completed before loading.

Trainings are every working day at 8:00 a.m., 10:00 a.m. and at 2 p.m.

Please take into account the training dates, when planning the date and time of the first load.

Fees:
Your driver needs 1.20 € cash – for getting „HSE“ notebook

Other fees for issuing Permanent entry card are:

- ▶ 24 € entrance card for person
- ▶ 24 € vehicle entrance card
- ▶ 9 € entrance training

All other fees will be paid by Stercorat SLOVAKIA, s.r.o. and re-invoiced to your company.

Permanent entry card validity is one year. Stercorat SLOVAKIA, s.r.o. Kft will send you the email, before expiry of Permanent entry card. The fee for re-training and reactivating of Permanent entry card will be charged - 7.20 €.

TANK CLEANING CERTIFICATE

Your driver must provide proof of clean-up of the tank before filling at loading place / or send the tank cleaning certificate to logistics@stercorat.eu before loading together with this text:

„I hereby declare that the tanker ... (plate no.) was cleaned before loading“ or „I hereby declare that the tanker ... (plate no.) was transporting ATS, UAN or Ammonia water before loading Stercosul®“.

The operating time for loading Stercosul® is: Monday - Friday from 8:00 a.m. to 3:30 p.m.
